## CAMBRIDGE REALTY CAPITAL EXECUTIVE DESCRIBES WHAT COMES NEXT AFTER CLOSING ON HUD 232 LOAN

You've closed on your HUD loan. Now what?

Cambridge Realty Capital Companies Vice President Katie Trice says the next thing borrowers should do is read and pay close attention to all the closing documents, especially the regulatory agreements.

Cambridge is one of the nation's leading senior housing/healthcare lenders, with more than \$4.5 billion in closed transactions. The company has consistently ranked among the leading FHA-approved HUD Lean lenders in the country.

Trice says HUD requires annual audited financials on any real estate owned. Internally prepared financials on the operator are required on a quarterly and annual basis.

"Borrowers should work closely with their HUD lenders regarding any planned or completed capital improvements so they can be reimbursed in a timely manner," she advises.

She points out that a HUD loan escrows for property insurance and property taxes. It's the lender's job to handle these payments.

"Borrowers should immediately notify their HUD lender of any changes in the owner, operator or management entities."

Trice explains that a HUD Section 232 loan is a credit enhancement from the Department of Housing and Urban Development. The funding takes place by the selling of Ginnie Mae mortgage-backed securities.

HUD has the ability to provide long-term, fixed-rate permanent financing and construction financing. HUD loans offer a fixed rate with an 80 percent loan-to-value ratio, and have up to a 30-year term and amortization.

The non-recourse HUD loans are not callable and can be assumed, Trice says.

Privately owned since its founding in 1983 as a real estate investment banker specializing in commercial real estate properties, Cambridge today has three distinctive business units: FHA-insured HUD loans, conventional financing, and investments and acquisitions. The company is one of the nation's leading nursing home, <u>assisted living</u> and healthcare debt and equity capital providers, with more than 400 closed transactions totaling more than \$4.5 billion since the early 1990's, when the firm began its specialization in providing senior housing capital.
